INFORMATION & RULES

- 1. The school fee is payable for the entire academic session of 2024-25. The fees can be paid either in full, at the beginning of the year or as per the schedule given below.
- A Student will be considered as continuing in the next session only on the payment of the 1st installment of the fees by 20th April 2024.
- 3. In case of non-payment of monthly fee installment, by the due date of the respective month, a late payment charge @ Rs. 500/-per month for April which will be compounded by Rs. 100/- per month and part month until clearance. Late fee from May June onwards shall be Rs. 200/- per month which will be compounded by Rs. 100/- per month and part month until clearance.

Eg- If the payment for April installment is done within 20th April, then no late fee will be applicable, if paid after 20th April and within 30th April, then a late fee of Rs. 500/- will be applicable and if paid in the month of May, then a late fee of Rs. 600/- will be applicable.

Eg- If the payment for May -June installment is done within 20th May, then no late fee will be applicable, if paid after 20th May till 31st May then a late fee of Rs. 200/- will be applicable and if paid in the month of June, then a late fee of Rs. 300/- will be applicable. In case of delay beyond 3 installments, clause no. 5 will be applicable.

- 4. Non-payment of fee for three installments will entail the student for de-enrollment from the rolls of the school without any further notice
- 5. Re-enrollment is subject to the availability of the seats & approval of the school management & the same will attract readmission fee of Rs. 4,000/-(Four thousand only) subject to the management approval & availability of the seats.
- 6. Fee-installment of any month cannot be considered as cleared without clearing previous outstanding.
- 7. Education fees are same as Tuition fees.
- 8. Lab fees are same as Practical fees.
- 9. No reduction in fees is made for holidays or broken periods.
- 10. Rs. 500/- will be charged for re-issue of the fee book if it is lost/damaged.
- 11. In case of withdrawal of a student, Guardians must give a written application to the Principal with one full calendar months' notice or a month's full fees in lieu thereof.
- 12. Transfer certificate charges applicable as Rs. 500/-.
- 13. Transfer certificate will not be issued before all dues are fully paid.
- 14. Students are liable to be charged as long as their names have not been struck-off (TC) from the rolls.
- 15. Fees once paid are not refundable under any circumstances.
- 16. Parents are requested to update the fee paid details in the Almanac for easy reference (Please refer to Almanac Page-49).

INSTALLMENTS & MODES OF PAYMENT
